Contract Notes - MC06-G13 Moving – Interstate

General Notes Using This Contract:

1. This contract has been awarded to Conlon/United, Daniel/Atlas and Sitterly/Allied (in cooperation with ABC Relocation in Clinton, MA).
2. The contract is based on the new DOT Tariff 400N. Vendors should not use 400M or any prior Tariff to quote rates.
3. The contract may be used by Faculty and Staff for personal moves, including those that are retiring and moving out of state.

NOTE: Insurance on personal moves is "Free" for Sitterly-Allied, Daniel-Atlas and Conlon-United.

4. It is strongly suggested you choose your preferred van line (Allied, Atlas or United) and call for one moving quote since the discounts are so close.

5. If your move is going to go into storage and be moved again, choose a van line that has its warehouse close to your destination.

Sitterly - Deerfield & Springfield, MA

ABC - Clinton, MA

Daniel - Franklin, MA

Conlon - Seekonk, MA

Drayage from storage is based on weight and mileage.

6. All vendors can provide references.
7. All vendors have waived the seasonal rate surcharge.
8. Fuel surcharge, based on DOE National U.S. Average, will apply.
9. All include guaranteed pick-up and delivery.

Instructions and Information pertaining to the use of this contract

Moving – Interstate **MC06-G13 Contract Duration from 05/01/2006 through 04/30/2009**

1. The member schools and their employees may use this contract for moves. Various types of purchase orders may be issued against the contract by each respective school, with no dollar limit. Individual employees may use this contract for personal moves and they shall be personally liable for all charges, less applicable discounts.

2. TO USE THIS CONTRACT: Departments, or the individual being moved, should contact the van line vendor of their choice listed below. (It is suggested you NOT call all three for estimates since they are essentially tied.) These vendors will contact the appropriate agent at the origination of the move point and that agent will contact the person to be moved. This contract may be reproduced and a copy may be sent to the person that is moving.

I REPEAT: YOU MUST START WITH THE VENDOR LISTED ON THIS CONTRACT TO GET THE MHEC CONTRACT DISCOUNT.

All moves should be done using the new 400N tariff.

3. If being covered by a school purchase order, the vendor will issue a separate invoice to the respective school for each purchase order received against the contract. If split between the school and the person being moved, the person being moved should use a major credit card or pay COD for their part. Each purchase order issued against this contract should be marked, "MASSACHUSETTS CONSORTIUM CONTRACT--MOVING."

4. Orders may be phoned in to the vendor if confirming orders are authorized by your school. All phone orders must be confirmed in writing and clearly marked, "CONFIRMATION--DO NOT DUPLICATE."

5. Use of the contract is left to the discretion of each respective school or employee. No guarantee of volume has been made to the vendor.

6. Note: State schools intrastate moves are governed by and subject to the rates published by the Department of Public Utilities. This Contract covers only Interstate moves.
